

Skynamo Competition Terms

- 1. The competition is run by Skynamo (Pty) Ltd ("Skynamo" and "We") from 31 July 2024 to 30 August 2024.
- 2. **Agreement to Rules**: By participating in the competition, the contestant ("you") agree to be fully and unconditionally bound by the competition rules as set out in this page ("the Rules") .). In addition, Youyou agree to accept the decisions of Skynamo as final and binding as it relates to the competition.
- 3. Campaign Period and Format: Entries will be accepted starting 31 July 2024 and will be accepted up to and including 30 August 2024. The campaign will run for this duration, and one winner will be chosen based on entries received during that period based on the competition criteria.
